

EVIDENCE AT THE SCENE INDICATED THE VEHICLE HAD BEEN EASTBOUND AND HAD GOME OFF THE ROADWAY, STRUCK SOME TREES, SPUN AROUND, AND COME TO REST FACING THE WRONG WAY IN THE EASTBOUND LANE. THE DRIVERS SIDE OF THE WINDSHIELD WAS CRACKED AND BOTH FRONT AIR BAGS HAD DEPLOYED.

IN PLAIN SEIGHT BEHIND THE DRIVERS SEAT OF THE WEHICLE I COULD SEE A BOX OF FRANZIA WINE. I COULD ALSO SEE RED LIQUID ON THE DRIVERS SIDE DOOR AND CEILING OF THE CAR.

I MADE A SEARCH OF THE ROADWAY IN THE AREA OF THE ACCIDENT. I WAS ASSISTED BY FIRE, EMS PERSONNEL AND A RESIDENT OF THE AREA. THE DRIVER WAS NOT LOCATED. A LATER SEARCH OF THE VEHICLE INDICATED THE DRIVER WAS MAURA MURRAY.

WHEN THE VEHICLE WAS TOWED FROM THE SCENE BY LAVOIE'S I RECOVERED A CORE BOTTLE THAT CONTAINED A RED LIQUID WITH A STRONG ALCOHOLIC ODOR. SEE HPD CASE \$04-179-OF FOR FURTHER DETAILS.
